- 1. Candidature of candidates shown **Eligible** (**E**) is purely provisional and is based on preliminary scrutiny of information provided by them. It creates no right in favour of any candidate and Institute reserves the right to debar a candidate for further stages of recruitment if information provided is found to be false/ incomplete.
