Instructions for Eligible (E) / Provisionally Eligible (PE) and Not Eligible (NE) candidates for the post of Assistant Professor (Grade II) (On contract) in Dept. of Computer Science and Engineering, IIIT Bhopal

1. Candidature of candidates shown **Eligible (E)** is purely provisional and is based on preliminary scrutiny of information provided by them. It creates no right in favour of any candidate and Institute reserves the right to debar a candidate for further stages of recruitment if information provided is found to be false/ incomplete.
