The following is brought to attention of all the candidates:

- a) IIIT Bhopal shall not be responsible for arrangements concerning boarding and lodging of the applicants. There are possibilities that events as mentioned in the schedule (uploaded on the website of the institute) may go on till late in the evening hence applicants are advised to make their arrangement accordingly.
- b) Mere calling for Presentation and Interview does not guarantee selection for the applied post.
- c) It will be the responsibility of the candidate to ensure that he/she is eligible as per the Advertisement. The Institute shall not be responsible for any error/omission/commission/suppression of any information provided by the applicants, knowingly or unknowingly, while filling up the application form. In case the applicant gets shortlisted/selected on the basis of incorrect, forged, or fabricated details, his/her candidature shall be liable to be cancelled at any stage of recruitment and appropriate legal action under applicable law shall be initiated against such applicants.
- d) No correspondence will be entertained from candidates who were found not eligible for the aforesaid posts. Any kind of interim queries on result or on aspects already clarified in advertisement and instructions shall not be entertained.

- f) Candidates must bring their presentation slides in a pen-drive and keep a copy in their e-mail.
- g) **The final merit list of the candidates will be prepared only for those candidates who qualifies as per the total aggregate scored in the presentation and interview as mentioned below: -**
  - a. **Category – UR, OBC-NCL = 50% and above**
  - b. **Category – SC, ST, PwD = 45% and above**
- h) Reservation policy at the institute will be followed as per Govt. of India norms.
- i) All the original documents will be verified before the presentation and interview.

- j) Presentation and Interview will be conducted only in offline mode. However, candidates from abroad, Person with Disability (PwD) and critical medical conditions etc. on case to case basis, may be allowed for online presentation and interview based upon the request of such candidates.
